MEMORANDUM OF ASSOCIATION

OF

CHINA SUN CORPORATION

A COMPANY LIMITED BY SHARES

1. NAME

The name of the Company is CHINA SUN CORPORATION.

2. INCORPORATION

The Company is incorporated as a company limited by shares.

3. **REGISTERED OFFICE**

The first registered office of the Company shall be situated at the office of the first Registered Agent at CCS Trustees Limited, Mandar House, 3rd Floor, Johnson's Ghut, Tortola, British Virgin Islands.

4. REGISTERED AGENT

The first registered agent of the Company shall be at CCS Trustees Limited, Mandar House, 3rd Floor, Johnson's Ghut, Tortola, British Virgin Islands.

5. **OBJECTS AND POWERS**

- (a) The object for which the Company is incorporated is to engage without limitation in any act or activities, irrespective of corporate benefit, which are not prohibited under any law for the time being in force in the British Virgin Islands.
- (b) The Company shall have full capacity, power, right, and privilege to:
 - (i) engage in any business or businesses whatsoever, or in any act or activities which are not prohibited under any law for the time being in force in the British Virgin Islands;
 - (ii) subject to licensing for regulated activity, carry on business with persons resident in the British Virgin Islands;
 - (iii) carry on banking or trust business, pursuant to a license issued to it under the Banks and Trust Companies Act, 1990, as amended, and to act as trustee of a Virgin Islands Special Trust;
 - (iv) carry on business as an insurance company or as a reinsurance company, insurance agent, or insurance broker, pursuant to a license issued to it under the Insurance Act, 2008;

- (v) carry on the business of company management pursuant to a license issued to it under the Company Management Act, 1990, as amended;
- (vi) act as a custodian of shares in a company incorporated under the laws of the British Virgin Islands, pursuant to a license issued to it under the Financial Services Commission Act, 2001, as amended;
- (vii) issue, cancel or hold shares of one class or series which may be convertible to another class or series;
- (viii) issue, cancel, and hold treasury shares, grant options over unissued shares in the Company and treasury shares, issue securities that are converted into shares, and give financial assistance to any person in connection with the acquisition of its own shares;
- (ix) issue debentures, guarantee a liability or obligation of any person and secure any of its obligations by mortgage, pledge or other charge of any of its assets;
- (x) protect the assets of the Company for the benefit of the Company, its creditors and its members and, at the discretion of the directors, for any person having a direct or indirect interest in the Company;
- (xi) buy, sell, underwrite, invest in, exchange or otherwise acquire and hold, manage, develop, deal with and turn to account any bonds, debentures, shares, (whether fully paid or not) stocks, options, commodities, futures, forward contracts, notes or securities of Governments, States, municipalities, public authorities or public or private limited or unlimited companies in any part of the world, precious metals, gems, works of art and other articles of value and whether on a cash or margin basis and including short sales, and to lend money against the security of any of the aforementioned property;
- (xii) buy, own, hold, subdivide, lease, sell, rent, prepare building sites, construct, reconstruct, alter, improve, decorate, furnish, operate, maintain, reclaim or otherwise deal with and/or develop land and buildings and otherwise deal in real estate in all its branches, make advances upon the security of land or houses or other property or any interest therein, and whether erected or in course of erection and whether on first mortgage or charge or subject to prior mortgage or charge, and to develop land and buildings as may seem expedient to the Company;
- (xiii) borrow or raise money by the issue of debentures, debenture stock (perpetual or terminable), bonds, mortgages, or any other securities founded or based upon all or any of the assets or property of the Company or without any such security and upon such terms as to priority or otherwise as the Company may think fit;
- (xiv) do all such other things as are incidental to, or which the company may think conducive to the attainment of all the above objects, powers, rights and privileges.
- (c) For the purposes of section 9(4) of the Act, there are no limitations on the businesses that the Company may carry on.

6. SHARES IN THE COMPANY

- (1) The Company shall be authorised to issue a maximum of 50,000 shares with a par value of USD1.00 each in one single class or series.
- (2) The shares issued of one class or series may be converted to another class or series.

- (3) The shares in the Company shall be issued in the currency of the United States of America.
- (4) Shares in the Company shall be issued as registered shares only.
- (5) The shares may be divided into such number of classes and series as the directors or members may by resolution from time to time determine, and until so divided shall comprise one class and series.
- (6) The Company shall not be authorized to issue bearer shares; convert registered shares to bearer shares; nor exchange registered shares for bearer shares.

7. DESIGNATIONS, RIGHTS, PRIVILEGES, RESTRICTIONS AND CONDITIONS ATTACHING TO SHARES

The directors or members shall by resolution have the power to issue any class or series of shares that the Company is authorized to issue, with or subject to any designations, powers, preferences, rights, qualifications, limitations and restrictions.

8. VARIATION OF CLASS RIGHTS

If at any time the number of shares which the Company is authorised to issue is divided into different classes of shares, the rights attached to any class (unless otherwise provided by the terms of issue of the shares of that class) shall whether or not the Company is being wound up, be varied by a resolution with the consent in writing of the holders of a majority in excess of 50% of the issued shares of that class and of the holders of not less than 30% of the issued shares of any other class of shares which may be affected by such variation.

9. RIGHTS NOT VARIED BY THE ISSUE OF SHARES PART PASSU

Rights conferred upon the holders of the shares of any class issued with preferred or other rights shall not, unless otherwise expressly provided by the terms of issue of the shares of that class, be deemed to be varied by the creation or issue of such further shares ranking pari passu therewith.

10. AMENDMENTS

- (1) The Company may by resolution of the members or by a resolution of directors, amend this Memorandum of Association and the Articles of Association of the Company.
- (2) Amendments to this Memorandum of Association and to the Articles of Association may include changing the name of the Company; and increasing the number of shares which the Company is authorised to issue.
- (3) No amendment may be made by a Resolution of Directors:
 - (i) to restrict the rights or powers of members to amend the memorandum of association or the articles of association;
 - (ii) to change the percentage of members required to pass a resolution of members to amend the memorandum of association or articles of association;
 - (iii) to clauses 7, 8, 9, and 10 of this Memorandum;
 - (iv) to prohibit members from amending the memorandum of association or articles of association; and

INTERPRETATION

- References in these Articles to the "Act" shall mean the BVI Business Companies Act, 2004, and 1. shall include amendments to the Act and such regulations as may from time be made under the Act.
- 2. (1) The following Regulations shall constitute the Articles of the Company.
 - (2) In these Articles words and expressions defined in the Act shall have the same meaning.
 - (3) Unless otherwise required by the context, the singular shall include the plural and vice versa, and the masculine gender shall include the feminine and the neuter genders.
 - References to "person" shall include corporations and all other entities which are capable of having a legal existence.

APPOINTMENT OF REGISTERED AGENT

A Registered Agent, with the exception of the First Registered Agent, may be appointed by a 3. Resolution of the Members or by a Resolution of the Directors.

ISSUE OF SHARES AND VARIATION OF RIGHTS

- Subject to the provisions of these Articles, the unissued shares of the Company shall be at the 4. (1) disposal of the directors who may offer, allot, grant options over, or otherwise dispose of them to such persons at such times and for such consideration, and upon such terms and conditions as the directors may determine.
 - Section 46 of the Act in respect of pre-emptive rights shall not apply to the issue, allotment, transfer, purchase, redemption, or acquisition of shares in the Company.
 - (3) The Company shall not be authorized to issue bearer shares; convert registered shares to bearer shares; or exchange registered shares for bearer shares.
 - (4) The directors shall issue no shares for a consideration other than money, unless the directors have passed a resolution stating:
 - (a) the amount to be credited for the issue of the Shares;
 - (b) their determination of the reasonable present cash value of the non-monetary consideration for the issue; and
 - (c) that, in their opinion, the present cash value of the non-monetary consideration for the issue is not less that the amount to be credited for the issue of the Shares.

- (5) The directors shall not issue a share for consideration which shall be less than the par value of the share.
- The directors may issue shares in the Company with such preferred, deferred, convertible or other 5. special rights or such restrictions, whether in regard to dividend, voting, return of capital or otherwise as the directors may determine.
- Shares issued in one class or series may be converted to another class or series; 6.
 - No shares issued by the Company in one class or series may be converted to another class or series without the written consent of the holder of the share;
 - The directors shall by a Resolution of directors determine the class or series to be converted to another class or series.
- The Company shall keep and maintain a register of members which shall contain the following: 7.
 - the names and addresses of the persons who hold registered shares in the Company;
 - (b) the number of each class and series of shares held by each shareholder;
 - the date on which the name of each shareholder was entered in the register of members; and
 - (d) the date on which a person ceased to be a shareholder of the Company.
- Every person whose name is entered as a member in the register of members, being the holder of shares shall, without payment, be entitled to a certificate signed by two directors or two officers or by one director or one officer of the Company or under the common seal of the Company with or without the signature of any director or officer of the Company.
 - The certificate shall specify the share or shares held and the par value thereof (if any) provided that in respect of a share, or shares, held jointly by several persons, the Company shall not be bound to issue more than one certificate, and delivery of a certificate for a share to one of several joint holders shall be sufficient delivery to all.
 - If a certificate is worn out or lost it may be renewed on production of the worn out certificate, or on satisfactory proof of its loss together with such indemnity as the directors may reasonably require.
 - Any member receiving a share certificate shall indemnify and hold the Company and its officers harmless from any loss or liability which it or they may incur by reason of wrongful or fraudulent use or representation made by any person by virtue of the possession of such a certificate.
- A share issued by the Company upon conversion of, or in exchange for, another share or a debt 9. obligation or other security in the Company, shall be treated for all purposes as having been issued for money equal to the consideration received or deemed to have been received by the Company in respect of the other share, debt obligation or security.
- The Company may issue fractions of a share and a fractional share shall have the same 10. corresponding fractional liabilities, limitations, preferences, privileges, qualifications, restrictions, rights and other attributes of a whole share of the same class or series of shares.
- The consideration in respect of the shares constitutes capital to the extent designated by the directors 11. and the excess constitutes surplus, except that the directors must designate as capital an amount of the consideration that is at least equal to the amount that the share is entitled to as a preference, if any, in the assets of the Company upon liquidation of the Company

12. Subject to the provisions of the Act, shares may be issued on the terms that they are redeemable, or at the option of the Company be liable to be redeemed on such terms and in such manner as the directors before or at any time of the issue of the shares may determine.

ACQUISITION OF OWN SHARES AND REDEMPTION OF SHARES

- The directors may, in accordance with the Act, on behalf of the Company purchase, redeem, or otherwise acquire any of the Company's own shares for such consideration as they consider fit, and may either cancel or hold such shares as treasury shares.
 - The directors may dispose of any shares held as treasury shares on such terms and conditions as they may from time to time determine. Shares may be purchased or otherwise acquired in exchange for newly issued shares in the Company.
 - (3) The directors may redeem any such share at a premium.
 - The directors shall by resolution determine whether sections 60, 61, and 62 of the Act shall apply to the acquisition of shares.
 - Upon cancellation of a share, the amount included as capital of the Company with respect to that share shall be deducted from the capital of the Company.
- Except as required by law, no person shall be recognized by the Company as holding any share 14. upon any trust, and the Company shall not be bound by or be compelled in any way to recognize (even when having notice thereof) any equitable, contingent, future, or partial interest in any share or any interest in any fractional part of a share.

TRANSFER OF SHARES

- Shares in the Company may be transferred by a written instrument signed by the transferor and 15.(1) containing the name and address of the transferee or such other manner or form and subject to such evidence as the directors shall consider appropriate.
 - The instrument of transfer shall be signed by the transferee if registration as a holder of the share imposes a liability to the Company on the transferee.
 - The instrument of transfer of a registered share shall be sent to the Company for registration.
- The Company shall register a transfer of shares by entering the name of the transferee of the shares 16.(1) in the register of members, if the directors are satisfied.
 - If the directors of the Company are satisfied that an instrument of transfer relating to Shares has been signed but that the instrument has been lost or destroyed, they may resolve by Resolution:
 - (a) to accept such evidence of the transfer of shares as they consider appropriate; and
 - that the transferee's name should be entered in the register of members notwithstanding the absence of the instrument of transfer.

TRANSMISSION OF SHARES

The personal representative of a deceased member, the guardian of an incompetent member, or the trustee of a bankrupt member shall be the only person recognized by the Company as having any title to his share.

- (3) The production to the Company of any document which is evidence of:
 - a grant of probate of the will, or grant of letters of administration of the estate, or confirmation of the appointment as executor, of a deceased member; or
 - (b) the appointment of a guardian of an incompetent member; or
 - the trustee of a bankrupt member; or
 - (d) any other documentation providing reasonable evidence of the applicants beneficial ownership of the shares,

shall be accepted by the Company.

- If the deceased, incompetent member or bankrupt member is domiciled outside the British Virgin Islands the Company shall accept the documents referred to in sub-regulation (3) above, if such documents are issued by a foreign court which had competent jurisdiction in the matter.
- For the purposes of establishing whether or not a foreign court had competent jurisdiction in the matter the directors may obtain appropriate legal advice.
- The directors may also require an indemnity to be given by the personal representative, guardian, or trustee of the member.
- An application by any such person to be registered as a member shall for all purposes be deemed to 18. be a transfer of shares of the deceased, incompetent, or bankrupt member and the directors shall treat it as such.
- Any person who has become entitled to a share in consequence of the death, incompetence, or 19. bankruptcy of any member may, instead of being registered himself, request in writing that some person to be named by him be registered as the transferee of such share and such request shall likewise be treated as if it were a transfer.
- What amounts to incompetence on the part of a person is a matter to be determined by the court 20. having regard to all the relevant evidence and the circumstances of the case.

LIEN

- The Company shall have a first and paramount lien on every share which has been registered in the name of a member, whether singly or jointly with any other person, for all the debts incurred before or after the notice to the Company of any interest of any person other than such member, and whether the time for the payment or discharge of the same shall have actually arrived or not, and notwithstanding that the same are joint debts or liabilities of such member or his estate and any other person, whether a member of the Company or not.
 - (2) The Company's lien on a share shall extend to all dividends payable thereon.
 - The directors may at any time either generally, or in any particular case, waive any lien that has arisen or may declare any share to be wholly or in part exempt from the provisions of this regulation.
- The Company may sell, in such manner as the directors may by resolution determine, any share on 22. which the Company has a lien, but no sale shall be made unless the sum in respect of which the lien exists is payable nor until the expiration of twenty one days after a notice in writing, demanding payment of the sum payable and giving notice of the intention to sell; in default of such payment, has been served on the holder of the share for the time being lang Int I Business Consulting (IIK) Limited

- 23. (1) The net proceeds of the sale by the Company of any share on which it has a lien shall be applied in or towards payment in respect of which the lien exists so far as the same is payable and any residue shall (subject to a like lien for debts or liabilities not payable as existed upon the share prior to the sale) be paid to the holder of the share immediately before such sale.
 - (2) For giving effect to any such sale the directors may authorise some person to transfer the share sold to the purchaser thereof.
 - (3) The purchaser shall be registered as the holder of the share and he shall not be bound to see the application of the purchase money, nor shall his title to the share be affected by any irregularity or invalidity in the proceedings in reference to the sale.

MEETINGS OF MEMBERS

- 24. The directors shall convene meetings of the members of the Company at such times and in such manner and place as the directors consider necessary or desirable, and they shall convene such a meeting upon the written request of members holding no less than 30% of the votes of the issued voting shares in the Company.
- 25. Seven days notice at the least specifying the place, the day and the hour of the meeting and general nature of the business to be conducted shall be given in the manner hereinafter mentioned to such persons whose names on the date the notice is given appear as members in the register of members of the Company and who are entitled to vote.
- 26. A meeting of the members shall be deemed to have been validly held, notwithstanding that it is held in contravention of the requirement to give notice.
- 27. Notice of the meeting is waived by an absolute majority in number of the members having a right to attend and vote at the meeting.
- 28. The inadvertent failure of the directors to give notice of a meeting to a member, or the fact that a member has not received the notice, does not invalidate the meeting.
- 29. A meeting of the members may on the application of a member or director of the Company be ordered by the Court if:
 - (a) it is impracticable to call or conduct a meeting of the members of a company in the manner specified in the Act or in these Articles; or
 - (b) if it is in the interest of the members of the Company that a meeting of members is held.

PROCEEDINGS AT MEETINGS OF MEMBERS

- 30. No business shall be transacted at any meeting unless a quorum of members is present at the time when the meeting proceeds to business. A quorum shall consist of the holder or holders present in person or by proxy of a majority of more than 50% of the voting shares.
- 31. If, within half an hour from the time appointed for the meeting, a quorum is not present, the meeting shall be dissolved.
- 32. At every meeting the members present shall choose someone of their number to be the chairman. If the members are unable to choose a chairman for any reason, then the person representing the greatest number of shares entitled to vote and who is present at the meeting shall preside as chairman failing which the oldest individual person shall take the chair.

- 33. The chairman may, with the consent of the meeting, adjourn any meeting from time to time, and from place to place, but no business shall be transacted at any adjourned meeting other than the business left unfinished at the meeting from which the adjournment took place.
- 34. At any meeting, a resolution put to the vote shall be decided on a show of hands by a simple majority unless a poll is (before or on the declaration of the result of the show of hands) demanded:
 - (a) by the chairman; or
 - (b) by any member present in person, voting trustee, committee or by proxy and representing not less than one tenth of the shares entitled to vote.
- Unless a poll be so demanded, a declaration by the chairman that a resolution has, on a show of hands, been carried, and an entry to that effect in the book containing the minutes of the proceedings of the Company, shall be sufficient evidence of the fact, without proof of the number or proportion of the votes recorded in favour of or against such resolution.
- 36. If a poll is duly demanded it shall be taken in such manner as the chairman directs, and the result of the poll shall be deemed to be the resolution of the meeting at which the poll was demanded.
- 37. The demand for a poll may be withdrawn.
- In the case of an equality of votes, whether on a show of hands, or on a poll, the chairman of the meeting at which the show of hands takes place, or at which the poll is demanded, shall be entitled to a second or casting vote.

VOTES OF MEMBERS

- 39. At any meeting of members whether on a show of hands or on a poll, every member entitled to vote and who is present in person, by a voting trustee, by a committee, or by proxy shall have one vote for every voting share of which he is the holder.
- 40. A member may be represented at a meeting of members by a voting trustee, by a committee, or by proxy who may speak and vote on behalf of that member.
- 41. A resolution which has been notified to all members and which has been approved by a majority in excess of 50% of the votes of those members in the form of one or more documents in writing or by telex, telegram, cable, or other written electronic communication shall forthwith, without the need for any notice, become effectual as a resolution of the members.
- 42. If a committee shall be appointed for any member who is entitled to vote and who is of unsound mind that member may vote by his committee.
- 43. If two or more persons are jointly entitled to a share or shares and if more than one of such persons shall vote in person or by voting trustee or by committee or by proxy at any meeting of members, the vote of that person whose name appears first among such voting joint holders in the register of members shall alone be counted.
- The instrument appointing a proxy shall be in such form as the chairman of the meeting shall accept as properly evidencing the wishes of the member appointing the proxy.
- The instrument appointing a proxy shall be in writing under the hand of the appointer unless the appointer is a corporation or other form of legal entity other than one or more individuals holding as joint owners in which case the instrument appointing a proxy shall be in writing under the hand of an individual duly authorised by such corporation or legal thirty to execute the same.

- The instrument appointing a proxy shall be produced at the place appointed for the meeting before 47. the time for holding the meeting at which the person named in such instrument proposes to vote.
- A member of the Company shall be deemed to be present at a meeting of members if: 48.
 - he participates by telephone or other electronic means; and
 - all members participating in the meeting are able to hear each other.

CORPORATIONS ACTING BY REPRESENTATIVES AT MEETINGS

- A corporation or other form of corporate legal entity which is a member of the Company may by 49. resolution of its directors or other governing body authorise such person as it thinks fit to act as its representative at any meeting of the members of the Company, and the person so authorised shall be entitled to exercise the same powers on behalf of the corporation which he represents as that corporation could exercise if it were an individual member of the Company.
- An action that may be taken by members of the Company at a meeting of members may also be 50. taken by a resolution of members consented to in writing, or by telex, telegram, cable, or other written electronic communication without the need for any notice.
- A resolution consented to in writing may consist of several documents including electronic 51. communication in like form each signed or assented to by one or more members.

DIRECTORS

- The number of the directors shall be not less than one nor more than fifteen. 52.
